

ICTs for Well-Being, Inclusion and Resilience: WSIS Cooperation for Accelerating Progress on the SDGs

(World Summit Information Society (WSIS) Secretariat)

Background

This meeting on the regional WSIS implementation activities will provide a platform for information sharing and collection of regional inputs on the implementation of the WSIS outcomes, in particular the WSIS Action Lines, towards the achievement of Sustainable Development Goals (SDGs). The vital role of information and communication technologies (ICTs) as a catalyst for development is specifically recognized in the development framework “Transforming Our World: The 2030 Agenda for Sustainable Development”, which acknowledges that “the spread of information and communication technology and global interconnectedness has great potential to accelerate human progress and to develop knowledge societies, to bridge the digital divide and to develop knowledge societies, as does scientific and technological innovation across areas as diverse as medicine and energy”. To that end, the WSIS-SDGs Matrix, developed by the UN Action Line Facilitators, clearly shows the linkage between each Action Line and the 17 SDGs, and provides rationale for each (www.wsis.org/sdg).

More specifically, the main purpose of this meeting is to provide a platform for stakeholders, in particular the WSIS Action Line Facilitators, international and regional organizations, experts, and government representatives, implementing the WSIS Action Lines at the regional level, to share good practices, foster partnerships, identify regional challenges and opportunities, while strengthening alignment between implementation of the WSIS and SDGs. This meeting will provide structured opportunities to network, learn, and participate in multistakeholder discussions and consultations on the WSIS implementation.

In this context, this meeting will focus on sharing of best practices and flagship initiatives, such as

- Emerging trends, challenges, and opportunities in building inclusive information and knowledge societies (WSIS Action Line Facilitators)
- Sharing of best practices (WSIS Prizes Winners from the region) and flagship initiatives (relevant stakeholders)
- Multistakeholder discussion on strengthening implementation of WSIS Action Lines to accelerate the achievement of the SDGs
- Contributions of the Open Consultation Process for the WSIS Forum 2022
- Interagency collaboration on ICT for sharing of information and best practices from national, regional, and global experiences, including the WSIS Prizes Winner 2021.

The outcomes of this meeting will serve as inputs to the WSIS Forum 2022 (15 March onwards until the final week on 30 May – 3 June 2022) and its open consultation process, WSIS Stocktaking, WSIS Prizes, thereby bringing to forefront emerging trends, opportunities, and challenges from the regional layer in a multi-stakeholder format. Regional good practices shared will be highlighted at the global level within the framework of the official WSIS Stocktaking process. The WSIS Forum 2022 Calls to Action are listed as Annex 1 below.

The United Nations Regional Commissions (UNRCs), including ESCWA, play an active role in the WSIS process and the discussions at the annual WSIS Forum to strengthen the implementation of the WSIS Action Lines for achieving the SDGs at the regional level. ESCWA continues its leading role in the WSIS process in the Arab region, including the regional preparatory activities.

The WSIS process is built on the framework of the 11 WSIS Action Lines that cover all aspects of ICTs for development. Since 2015, the WSIS process and the 2030 Agenda for Sustainable Development are being aligned by stakeholders to integrate ICTs into their approaches in implementing the activities/initiatives to support the implementation of the 2030 Agenda for Sustainable Development.

Description

This session will bring together various stakeholders and experts from different sectors to discuss how ICTs and the WSIS Action Lines can help accelerate the SDGs and focus on strengthening partnerships and digital cooperation towards achieving goals and targets across the 2030 Agenda for Sustainable Development.

It will also highlight the implementation of the WSIS Action Lines that contribute to the achievement of the SDGs in the Arab region.

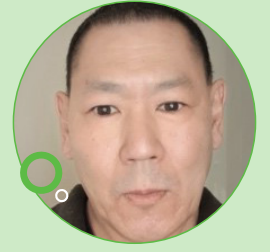
